

Note 1: If a reverse bias is applied between gate and source, this device enters $V_{(BR)DSX}$ mode. Note that the drain-source breakdown voltage is lowered in this mode.

Note 2: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (0.1 mA for this device). Then, for normal switching operation, V_{GS(ON)} must be higher than V_{th}, and V_{GS(OFF)} must be lower than V_{th}. This relationship can be expressed as: V_{GS(OFF)} < V_{th} < V_{GS(ON)}.

Take this into consideration when using the device.




Fig. 5.3.1 Test Circuit of Switching Time








Fig. 8.1 $I_D - V_{DS}$




Fig. 8.3 R_{DS(ON)} - V_{GS}




Fig. 8.5 R_{DS(ON)} - I_D




Fig. 8.2 I_D - V_{GS}




Fig. 8.4 R_{DS(ON)} - V_{GS}




Fig. 8.6 R_{DS(ON)} - T_a




Fig. 8.7 V_{th} - T_a




Fig. 8.8 I_{DR} - V_{DS}




Fig. 8.9 C - V_{DS}




Fig. 8.10 t-I_D




Fig. 8.11 Dynamic Input Characteristics




Fig. 8.12 r_{th} - t_w




Fig. 8.13 P_D - T_a





Fig. 8.14 Safe Operating Area
