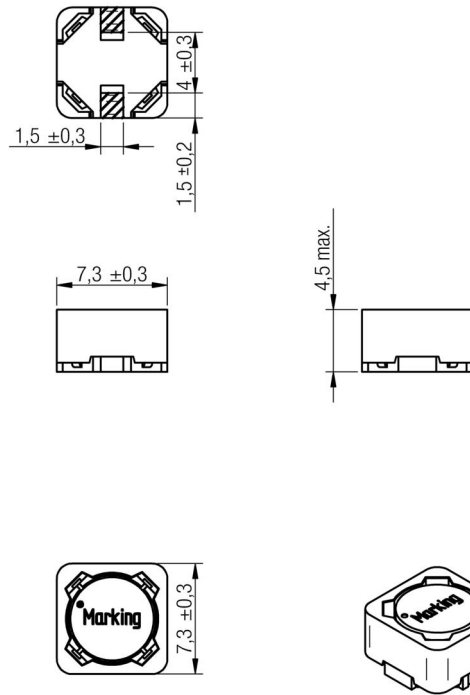

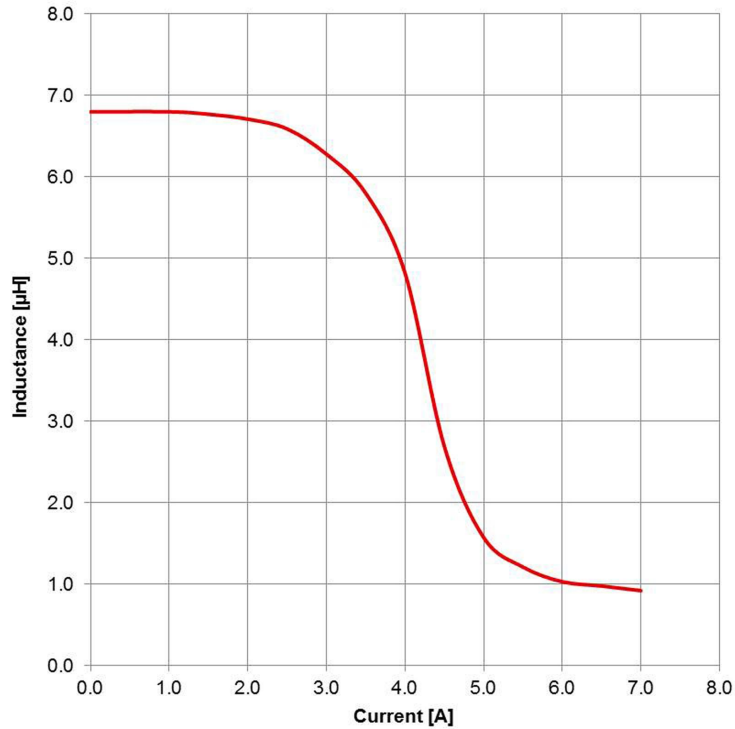

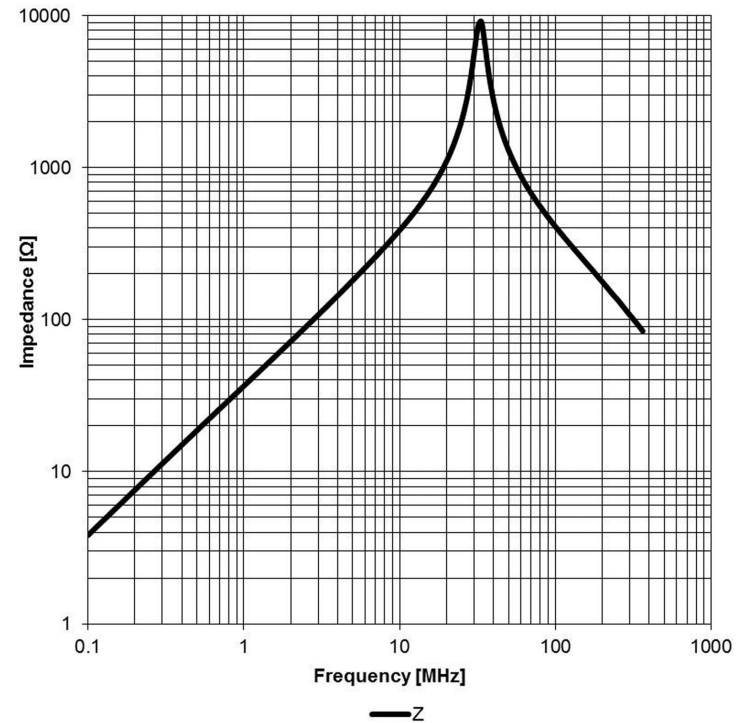

F2 Typical Impedance Characteristics:



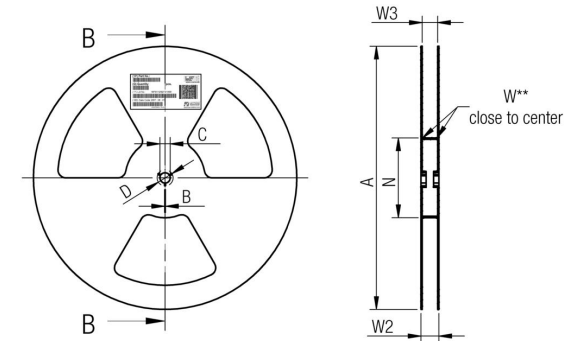



Product specific:
