


**Fig 1.** Typical Output Characteristics**Fig 2.** Typical Output Characteristics**Fig 3.** Typical Transfer Characteristics**Fig 4.** Normalized On-Resistance Vs. Temperature




**Fig 5.** Typical Capacitance Vs.  
Drain-to-Source Voltage




**Fig 6.** Typical Gate Charge Vs.  
Gate-to-Source Voltage




**Fig 7.** Typical Source-Drain Diode  
Forward Voltage




**Fig 8.** Maximum Safe Operating Area




**Fig 9a.** Basic Gate Charge Waveform




**Fig 10a.** Switching Time Test Circuit




**Fig 9b.** Gate Charge Test Circuit





**Fig 10b.** Switching Time Waveforms

**Fig 12a.** Unclamped Inductive Test Circuit




**Fig 12b.** Unclamped Inductive Waveforms


**Fig 12c.** Maximum Avalanche Energy Vs. Drain Current




