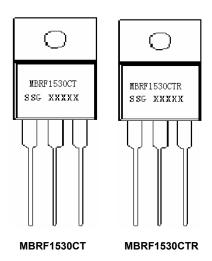

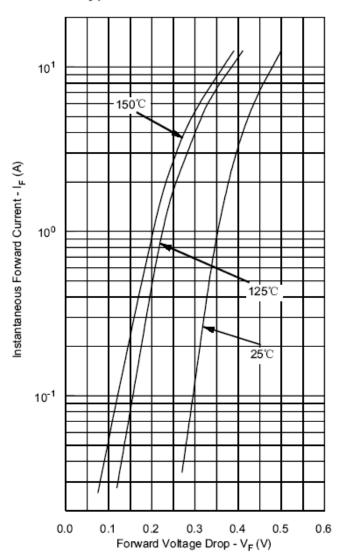

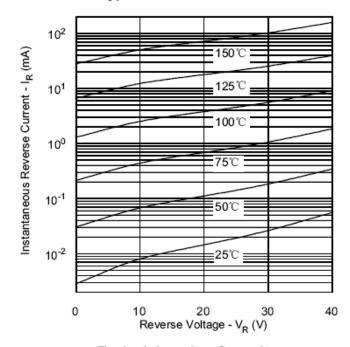

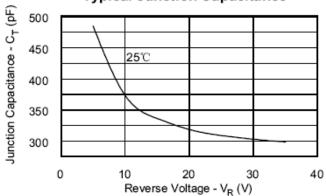
Typical Forward Characteristics
